RULES OF DECORUM

1. WE BELIEVE IT IS DUTY FOR THE MEMBERS OF THIS CHURCH TO FILL THEIR SEATS AT MEETING OF BE BUSINESS DO!

2. WHEN THE CHURCH IS READY TO ENTER ON BUSINESS, FIRST TO ATTEND TO THE REFERENCES, THEN TO ANY MATTER OF GREIVANCES, THEN TO RIGHT TO COME BEFORE THE CHURCH, AND THEN TO ANYTHING THAT DUTY CALLS OUR ATTENTION TO.

3. WHEN ANY MEMBER HAS SPOKEN TO A SUBJECT BEFORE THE CHURCH, CHURCH ONE SPEAKING AFTER, IS NOT TO REFLECT ON THE FORMER SPEAKER NOR TO STRIKE AT THEIR FEELINGS (FOR SUCH CONDUCT WOULD BE CONTRARY TO THE SPIRIT OF THE GOSPEL) AND THAT NO MEMBER ARES ARE TO SPEAK TO SUBJECT MORE THAN THREE TIMES WITHOUT LEAVE OF THE MODERATOR.

4. WHILE THE CHURCH IS ENGAGED IN BUSINESS THERE IS TO BE DUE ATTENTION PAID BY ALL THE MEMBERS PRESENT AND NOW WHISPERING AT SUCH TIMES AND EACH MEMBER ARE TO KEEP THEIR SEAT AND NOT TO DRAW WITHOUT LEAVE OF THE MODERATOR AND AND WHEN ANY QUESTION PUT TO THE CHURCH SUCH MEMBER IS TO VOTE OR GIVE THEIR REASON, AND EVERY MEMBER TO RECOLLECT THEY ARE NOT TO KNOW HIS FATHER IN JUDGMENT.

6. IN THE CASE OF PUBLICK GREIVANCES TENDERNESS AND FAITHFULLNESS OUGHT TO BE USED IN THE SPIRIT OF MEEKNESS ALLWAYS AIMING TO GAIN AND NOT TO EXCLUDE OUR BROTHER CONSIDERING OURSELVES LESS WE ALSO BE TEMPTED AND LET IT BEE KNOWN THAT PUBLICK GREVIENCES OUGHT TO HAVE PUBLICK CONFESSIONS.

7. IN CASE OF AN EVIL REPORT ABOUT A MEMBER, WE OUGHT TO TAKE THE MOST PRUDENT STEPS TO INFORM OURSELVES AS TO THE TRUTH OF IT AND IF IT APPEARS DUTY TO LAY IT BEFORE THE CHURCH, AND THEY TO ACT AS THE NATURE OF THE CASE MAY REQUIRE!

8. AS THE CHURCH OF CHRIST IS FOMPARED TO CITY SET UPON A HILL GIVING LIGHT TO EVER SPECTATOR WE CONCEIVE IT TO BE OUR DUTY TO LET OUR LIGHT SO SHINE BEFORE MEN, THAT THEY SEEING OUR GOOD WORKS MAY GLORIFY OUR FATHER WHICH IS IN HEAVEN, IT IS OUR DUTY TO SPEAK NO EVIL OF NO PERSON AND TREAT THOUSE THAT ARE OPPOSED TO RELIGEN WITH SO MUCH TENDERNESS AND RESPECT (FOR BUT NOT TO COUNTENANCE THEM) AS TO GIVE FULL PROOF THAT THERE IS SOMETHING IN US MORE THAN NATURE PRODUCES. WE ARE TO BE EXCEEDINGLY CAUTIOUS NOT TO

ARTICLES OF FAITH
